Principal Jeff Determan reported that prom that was on April 9<sup>th</sup> and it went well. The home middle school track meet is on April 11<sup>th</sup>. The Dakota Players Theatre group is at school the week of April 11<sup>th</sup> with the performance at 2:00 pm on the 15<sup>th</sup>. Students in grades BK-8 can participate. The home JV golf tournament and the middle school golf meet at Burke is on April 12<sup>th</sup>. There is an early dismissal at 1:30 pm on April 14<sup>th</sup>, with no school on April 15<sup>th</sup> and 18<sup>th</sup> for Easter break. The SDSU women's choir will perform on April 19<sup>th</sup> at 1:00 pm. Former student, Keeley Klein is a member of the choir that will be performing. April 25<sup>th</sup> is the 6-12 grade chorus concert at the auditorium. The 6-12 grade band concert is May 2<sup>nd</sup> at the Park Performance Center. The IOOF and Sunshine Club will have concessions available at the park. The high school play is April 29<sup>th</sup> and 30<sup>th</sup>. May 6<sup>th</sup> is the 5-8 grade instrumental contest at Winner. Awards banquet is May 9<sup>th</sup>. Elementary field trips are being planned and will be happening soon.

Superintendent Anderson stated that she has been in contact with the company about the security door system, but is still waiting for it to be installed.
